31 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

32 <u>NEW SECTION.</u> Sec. 1. The legislature intends by this act to 33 reorganize criminal provisions throughout the Revised Code of 34 Washington to clarify and simplify the identification and referencing 35 of crimes. It is not intended that this act effectuate any substantive 36 change to any criminal provision in the Revised Code of Washington.

1 Sec. 2. RCW 2.48.180 and 2001 c 310 s 2 are each amended to read 2 as follows:

3

(1) As used in this section:

4 (a) "Legal provider" means an active member in good standing of the
5 state bar, and any other person authorized by the Washington state
6 supreme court to engage in full or limited practice of law;

7 (b) "Nonlawyer" means a person to whom the Washington supreme court 8 has granted a limited authorization to practice law but who practices 9 law outside that authorization, and a person who is not an active 10 member in good standing of the state bar, including persons who are 11 disbarred or suspended from membership;

(c) "Ownership interest" means the right to control the affairs of a business, or the right to share in the profits of a business, and includes a loan to the business when the interest on the loan is based upon the income of the business or the loan carries more than a commercially reasonable rate of interest.

(2) The following constitutes unlawful practice of law:

(a) A nonlawyer practices law, or holds himself or herself out asentitled to practice law;

(b) A legal provider holds an investment or ownership interest in
a business primarily engaged in the practice of law, knowing that a
nonlawyer holds an investment or ownership interest in the business;

(c) A nonlawyer knowingly holds an investment or ownership interestin a business primarily engaged in the practice of law;

(d) A legal provider works for a business that is primarily engaged in the practice of law, knowing that a nonlawyer holds an investment or ownership interest in the business; or

(e) A nonlawyer shares legal fees with a legal provider.

29 (3)(a) Unlawful practice of law is a crime. A single violation of 30 this section is a gross misdemeanor.

31 (b) Each subsequent violation <u>of this section</u>, whether alleged in 32 the same or in subsequent prosecutions, is a class C felony <u>punishable</u> 33 <u>according to chapter 9A.20 RCW</u>.

34 (4) Nothing contained in this section affects the power of the
 35 courts to grant injunctive or other equitable relief or to punish as
 36 for contempt.

37 (5) Whenever a legal provider or a person licensed by the state in38 a business or profession is convicted, enjoined, or found liable for

1 damages or a civil penalty or other equitable relief under this 2 section, the plaintiff's attorney shall provide written notification of 3 the judgment to the appropriate regulatory or disciplinary body or 4 agency.

5 (6) A violation of this section is cause for discipline and 6 constitutes unprofessional conduct that could result in any regulatory 7 penalty provided by law, including refusal, revocation, or suspension 8 of a business or professional license, or right or admission to 9 practice. Conduct that constitutes a violation of this section is 10 unprofessional conduct in violation of RCW 18.130.180.

(7) In a proceeding under this section it is a defense if proven by the defendant by a preponderance of the evidence that, at the time of the offense, the conduct alleged was authorized by the rules of professional conduct or the admission to practice rules, or Washington business and professions licensing statutes or rules.

(8) Independent of authority granted to the attorney general, the 16 17 prosecuting attorney may petition the superior court for an injunction against a person who has violated this chapter. Remedies in an 18 injunctive action brought by a prosecuting attorney are limited to an 19 order enjoining, restraining, or preventing the doing of any act or 20 21 practice that constitutes a violation of this chapter and imposing a 22 civil penalty of up to five thousand dollars for each violation. The prevailing party in the action may, in the discretion of the court, 23 24 recover its reasonable investigative costs and the costs of the action 25 including a reasonable attorney's fee. The degree of proof required in 26 an action brought under this subsection is a preponderance of the 27 evidence. An action under this subsection must be brought within three 28 years after the violation of this chapter occurred.

29 Sec. 3. RCW 3.50.440 and 1984 c 258 s 120 are each amended to read 30 as follows:

Every person convicted by the municipal court of a violation of the criminal provisions of an ordinance for which no punishment is specifically prescribed in the ordinance <u>is quilty of a gross</u> <u>misdemeanor and</u> shall be punished by a fine of not more than five thousand dollars or imprisonment in the city jail for a period not to exceed one year, or both such fine and imprisonment.

(2) An action under this section shall be brought in the county in which the unlawful act or acts are alleged to have taken place, and shall be commenced by the filing of a verified complaint, or shall be accompanied by an affidavit.

(3) If it is shown to the satisfaction of the court, either by 25 26 verified complaint or affidavit, that a person is engaged in or about to engage in any act that constitutes a violation of RCW 9.26A.110, 27 section 21 of this act, or 9.26A.090, the court may issue a temporary 28 29 restraining order to abate and prevent the continuance or recurrence of 30 the act. The court may direct the sheriff to seize and retain until 31 further order of the court any device that is being used in violation of RCW 9.26A.110, section 21 of this act, or 9.26A.090. All property 32 seized pursuant to the order of the court shall remain in the custody 33 34 of the court.

35 (4) The court may issue a permanent injunction to restrain, abate
36 or prevent the continuance or recurrence of the violation of RCW
37 9.26A.110, section 21 of this act, or 9.26A.090. The court may grant

1 declaratory relief, mandatory orders, or any other relief deemed 2 necessary to accomplish the purposes of the injunction. The court may 3 retain jurisdiction of the case for the purpose of enforcing its 4 orders.

(5) If it is shown to the satisfaction of the court, either by 5 verified complaint or affidavit, that a person is engaged in or is б 7 about to engage in any act that constitutes a violation of RCW 9.26A.110, section 21 of this act, or 9.26A.090, the court may issue an 8 9 order which shall be promptly served upon the person in whose name the 10 telecommunications device is listed, requiring the party, within a reasonable time, to be fixed by the court, from the time of service of 11 12 the petition on ((said)) the party, to show cause before the judge why 13 telephone service should not promptly be discontinued. At the hearing 14 the burden of proof shall be on the complainant.

(6) Upon a finding by the court that the telecommunications device 15 is being used or has been used in violation of RCW 9.26A.110 or section 16 17 21 of this act, the court may issue an order requiring the telephone company which is rendering service over the device to disconnect such 18 service. Upon receipt of such order, which shall be served upon an 19 officer of the telephone company by the sheriff or deputy of the county 20 21 in which the telecommunications device is installed, the telephone 22 company shall proceed promptly to disconnect and remove such device and discontinue all telephone service until further order of the court, 23 24 provided that the telephone company may do so without breach of the 25 peace or trespass.

(7) The telecommunications company that petitions the court for the removal of any telecommunications device under this section shall be a necessary party to any proceeding or action arising out of or under RCW 9.26A.110 or section 21 of this act.

(8) No telephone company shall be liable for any damages, penalty,
 or forfeiture, whether civil or criminal, for any legal act performed
 in compliance with any order issued by the court.

(9) Property seized pursuant to the direction of the court that the court has determined to have been used in violation of RCW 9.26A.110 or section 21 of this act shall be forfeited after notice and hearing. The court may remit or mitigate the forfeiture upon terms and conditions as the court deems reasonable if it finds that such forfeiture was incurred without gross negligence or without any intent

of the petitioner to violate the law, or it finds the existence of such mitigating circumstances as to justify the remission or the mitigation of the forfeiture. In determining whether to remit or mitigate forfeiture, the court shall consider losses that may have been suffered by victims as the result of the use of the forfeited property.

8 Whenever two or more persons assemble for the purpose of committing 9 criminal sabotage, as defined in RCW 9.05.060, such an assembly is 10 unlawful, and every person voluntarily and knowingly participating 11 therein by his or her presence, aid, or instigation, <u>is quilty of a</u> 12 <u>class B felony and</u> shall be punished by imprisonment in a state 13 correctional facility for not more than ten years, or by a fine of not 14 more than five thousand dollars, or both.

15 **Sec. 7.** RCW 9.05.060 and 1999 c 191 s 2 are each amended to read 16 as follows:

(1) Whoever, with intent that his or her act shall, or with reason 17 18 to believe that it may, injure, interfere with, interrupt, supplant, nullify, impair, or obstruct the owner's or operator's management, 19 20 operation, or control of any agricultural, stockraising, lumbering, mining, quarrying, fishing, manufacturing, transportation, mercantile, 21 22 or building enterprise, or any other public or private business or 23 commercial enterprise, wherein any person is employed for wage, shall willfully damage or destroy, or attempt or threaten to damage or 24 25 destroy, any property whatsoever, or shall unlawfully take or retain, or attempt or threaten unlawfully to take or retain, possession or 26 control of any property, instrumentality, machine, mechanism, 27 or 28 appliance used in such business or enterprise, shall be guilty of 29 criminal sabotage.

30 (2) Criminal sabotage is a <u>class B</u> felony <u>punishable according to</u>

As used in RCW 9.08.070 and sections 10 through 13 of this act:

1 (1) "Pet animal" means a tamed or domesticated animal legally 2 retained by a person and kept as a companion. "Pet animal" does not 3 include livestock raised for commercial purposes.

4 (2) "Research institution" means a facility licensed by the United 5 States department of agriculture to use animals in biomedical or 6 product research.

7 (3) "U.S.D.A. licensed dealer" means a person who is licensed or
8 required to be licensed by the United States department of agriculture
9 to commercially buy, receive, sell, negotiate for sale, or transport
10 animals.

(a) Takes, leads away, confines, secretes or converts any pet
animal, except in cases in which the value of the pet animal exceeds

Whenever any inmate of a correctional institution shall hold, or participate in holding, any person as a hostage, by force or violence, or the threat thereof, or shall prevent, or participate in preventing an officer of such institution from carrying out his or her duties, by force or violence, or the threat thereof, he or she shall be guilty of a <u>class B</u> felony and upon conviction shall be punished by imprisonment in a state correctional institution for not less than one year nor more
 than ten years.

For offenders placed on community 27 custody for crimes committed on or after July 1, 2000, the department 28 shall assess the offender's risk of reoffense and may establish and 29 modify conditions of community custody, in addition to those imposed by 30 31 the court, based upon the risk to community safety.

32 (6) "Community custody range" means the minimum and maximum period
33 of community custody included as part of a sentence under RCW
34 9.94A.715, as established by the commission or the legislature under
35 RCW 9.94A.850, for crimes committed on or after July 1, 2000.

36 (7) "Community placement" means that period during which the 37 offender is subject to the conditions of community custody and/or postrelease supervision, which begins either upon completion of the term of confinement (postrelease supervision) or at such time as the offender is transferred to community custody in lieu of earned release. Community placement may consist of entirely community custody, entirely postrelease supervision, or a combination of the two.

6 (8) "Community restitution" means compulsory service, without 7 compensation, performed for the benefit of the community by the 8 offender.

(9) "Community supervision" means a period of time during which a 9 convicted offender is subject to crime-related prohibitions and other 10 sentence conditions imposed by a court pursuant to this chapter or RCW 11 16.52.200(6) or 46.61.524. Where the court finds that any offender has 12 13 a chemical dependency that has contributed to his or her offense, the 14 conditions of supervision may, subject to available resources, include treatment. For purposes of the interstate compact for out-of-state 15 supervision of parolees and probationers, RCW 9.95.270, community 16 17 supervision is the functional equivalent of probation and should be considered the same as probation by other states. 18

(10) "Confinement" means total or partial confinement.

(11) "Conviction" means an adjudication of guilt pursuant to Titles
10 or 13 RCW and includes a verdict of guilty, a finding of guilty, and
acceptance of a plea of guilty.

(12) "Crime-related prohibition" means an order of a court prohibiting conduct that directly relates to the circumstances of the crime for which the offender has been convicted, and shall not be construed to mean orders directing an offender affirmatively to participate in rehabilitative programs or to otherwise perform affirmative conduct. However, affirmative acts necessary to monitor compliance with the order of a court may be required by the department.

30 (13) "Criminal history" means the list of a defendant's prior 31 convictions and juvenile adjudications, whether in this state, in 32 federal court, or elsewhere.

33 (a) The history shall include, where known, for each conviction (i) 34 whether the defendant has been placed on probation and the length and 35 terms thereof; and (ii) whether the defendant has been incarcerated and 36 the length of incarceration.

(b) A conviction may be removed from a defendant's criminal history

a controlled substance (((RCW 69.50.401(d))) section 334 of this act)

9A.76.120), willful failure to return from furlough (RCW 72.66.060),

failure to be available for supervision by the department while in

At the time of the disposition, the court may set treatment review hearings as the court considers appropriate.

Except as provided in this subsection (3), after July 1, 1991, examinations and treatment ordered pursuant to this subsection shall only be conducted by sex offender treatment providers certified by the

department of health pursuant to chapter 18.155 RCW. (g) Copies of all invitations for tenders or advertisements making a tender offer to stockholders for purchase of their stock to be used in connection with the proposed acquisition.

Money retained 34 under this section may not be used to supplant preexisting funding 35 sources.

36 ((<del>(k)</del>)) <u>(11)</u> Controlled substances listed in Schedule I, II, III, 37 IV, and V that are possessed, transferred, sold, or offered for sale in 38 violation of this chapter are contraband and shall be seized and 1 summarily forfeited to the state. Upon making 23 a finding in writing that the animal problem has not been and cannot be 24 reasonably abated by nonlethal control tools or if the tools cannot be 25 reasonably applied, the director may authorize the use, setting, placing, or maintenance of the traps for a period not to exceed thirty 26 27 days.

(c) Nothing in this section prohibits the director from granting a special permit to department employees or agents to use traps listed in this subsection where the use of the traps is the only practical means of protecting threatened or endangered species as designated under RCW 77.08.010.

33 (d) Nothing in this section prohibits the director from issuing a 34 permit to use traps listed in this subsection, excluding Conibear 35 traps, for the conduct of legitimate wildlife research.

36 (5) Nothing in this section prohibits the United States fish and 37 wildlife service, its employees or agents, from using a trap listed in 38 subsection (4) of this section where the fish and wildlife service determines, in consultation with the director, that the use of such traps is necessary to protect species listed as threatened or endangered under the federal endangered species act (16 U.S.C. Sec. 1531 et seq.).
