BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

PART I
NEW TITLE CREATED

NEW SECTION. **Sec. 101.** This act is intended to make technical
amendments to certain codified statutes that involve campaign
disclosure and contribution. Any statutory changes made by this act
should be interpreted as technical in nature and not interpreted to
have any substantive, policy implications.

1 state or any municipal corporation, political subdivision, or other
2 voting constituency from and after the time when the proposition has
3 been initially filed with the appropriate election officer of that
4 constituency before its circulation for signatures.

5 NEW SECTION. **Sec. 206.** "Benefit" means a commercial,
6 proprietary, financial, economic, or monetary advantage, or the
7 avoidance of a commercial, proprietary, financial, economic, or
8 monetary disadvantage.

9 NEW SECTION. **Sec. 207.** "Bona fide political party" means:

10 (1) An organization that has been recognized as a minor political
11 party by the secretary of state;

12 (2) The governing body of the state organization of a major
13 political party, as defined in RCW 29A.04.086, that is the body
14 authorized by the charter or bylaws of the party to exercise
15 authority on behalf of the state party; or

16 (3) The county central committee or legislative district
17 committee of a major political party. There may be only one
18 legislative district committee for each party in each legislative
19 district.

20 NEW SECTION. **Sec. 208.** "Books of account" means:

21 (1) In the case of a campaign or political committee, a ledger or
22 similar listing of contributions, expenditures, and debts, such as a
23 campaign or committee is required to file regularly with the
24 commission, current as of the most recent business day; or

25 (2) In the case of a commercial advertiser, details of political
26 advertising or electioneering communications provided by the
27 advertiser, including the names and addresses of persons from whom it
28 accepted political advertising or electioneering communications, the
29 exact nature and extent of the services rendered, and the total cost
30 and the manner of payment for the services.

31 NEW SECTION. **Sec. 209.** "Candidate" means any individual who
32 seeks nomination for election or election to public office. An
33 individual seeks nomination or election when the individual first:

34 (1) Receives contributions or makes expenditures or reserves
35 space or facilities with intent to promote the individual's candidacy
36 for office;

(2) Announces publicly or files for office;

(3) Purchases commercial advertising space or broadcast time to promote the individual's candidacy; or

(4) Gives consent to another person to take on behalf of the individual any of the actions in subsection (1) or (3) of this section.

NEW SECTION. **Sec. 210.** "Caucus political committee" means a political committee organized and maintained by the members of a major political party in the state senate or state house of representatives.

NEW SECTION. **Sec. 211.** "Commercial advertiser" means any person that sells the service of communicating messages or producing material for broadcast or distribution to the general public or segments of the general public whether through brochures, fliers, newspapers, magazines, television, radio, billboards, direct mail advertising, printing, paid internet or digital communications, or any other means of mass communication used for the purpose of appealing, directly or indirectly, for votes or for financial or other support in any election campaign.

NEW SECTION. **Sec. 212.** "Commission" means the agency established under RCW 42.17A.100 (as recodified by this act).

NEW SECTION. **Sec. 213.** "Committee" unless the context indicates otherwise, includes a political committee such as a candidate, ballot proposition, recall, political, or continuing political committee.

NEW SECTION. **Sec. 214.** "Compensation" unless the context requires a narrower meaning, includes payment in any form for real or personal property or services of any kind. For the purpose of compliance with RCW 42.17A.710 (as recodified by this act), "compensation" does not include per diem allowances or other payments made by a governmental entity to reimburse a public official for expenses incurred while the official is engaged in the official business of the governmental entity.

NEW SECTION. **Sec. 215.** "Continuing political committee" means a political committee that is an organization of continuing existence

not limited to participation in any particular election campaign or election cycle.

NEW SECTION. Sec. 216. (1) "Contribution" includes:

(a) A loan, gift, deposit, subscription, forgiveness of indebtedness, donation, advance, pledge, payment, transfer of funds, or anything of value, including personal and professional services for less than full consideration;

(b) An expenditure made by a person in cooperation, consultation, or concert with, or at the request or suggestion of, a candidate, a political or incidental committee, the person or persons named on the candidate's or committee's registration form who direct expenditures on behalf of the candidate or committee, or their agents;

(c) The financing by a person of the dissemination, distribution, or republication, in whole or in part, of broadcast, written, graphic, digital, or other form of political advertising or electioneering communication prepared by a candidate, a political or incidental committee, or its authorized agent;

(d) Sums paid for tickets to fund-raising events such as dinners and parties, except for the actual cost of the consumables furnished at the event.

(2) "Contribution" does not include:

(a) Accrued interest on money deposited in a political or incidental committee's account;

(b) Ordinary home hospitality;

(c) A contribution received by a candidate or political or incidental committee that is returned to the contributor within 10 business days of the date on which it is received by the candidate or political or incidental committee;

(d) A news item, feature, commentary, or editorial in a regularly scheduled news medium that is of interest to the public, that is in a news medium controlled by a person whose business is that news medium, and that is not controlled by a candidate or a political or incidental committee;

(e) An internal political communication primarily limited to the members of or contributors to a political party organization or political or incidental committee, or to the officers, management staff, or stockholders of a corporation or similar enterprise, or to the members of a labor organization or other membership organization;

1 (f) The rendering of personal services of the sort commonly
2 performed by volunteer campaign workers, or incidental expenses
3 personally incurred by volunteer campaign workers not in excess of
4 \$50 personally paid for by the worker. "Volunteer services," for the
5 purposes of this section, means services or labor for which the
6 individual is not compensated by any person;

7 (g) Messages in the form of reader boards, banners, or yard or
8 window signs displayed on a person's own property or property
9 occupied by a person. However, a facility used for such political
10 advertising for which a rental charge is normally made must be
11 reported as an in-kind contribution and counts toward any applicable
12 contribution limit of the person providing the facility;

13 (h) Legal or accounting services rendered to or on behalf of:

14 (i) A political party or caucus political committee if the person
15 paying for the services is the regular employer of the person
16 rendering such services; or

17 (ii) A candidate or an authorized committee if the person paying
18 for the services is the regular employer of the individual rendering
19 the services and if the services are solely for the purpose of
20 ensuring compliance with state election or public disclosure laws; or

21 (i) The performance of ministerial functions by a person on
22 behalf of two or more candidates or political or incidental
23 committees either as volunteer services defined in (f) of this
24 subsection or for payment by the candidate or political or incidental
25 committee for whom the services are performed as long as:

26 (i) The person performs solely ministerial functions;

27 (ii) A person who is paid by two or more candidates or political
28 or incidental committees is identified by the candidates and
29 political committees on whose behalf services are performed as part
30 of their respective statements of organization under RCW 42.17A.205
31 (as recodified by this act); and

32 (iii) The person does not disclose, except as required by law,
33 any information regarding a candidate's or committee's plans,
34 projects, activities, or needs, or regarding a candidate's or
35 committee's contributions or expenditures that is not already
36 publicly available from campaign reports filed with the commission,
37 or otherwise engage in activity that constitutes a contribution under
38 subsection (1)(b) of this section.

39 A person who performs ministerial functions under this subsection
40 (2)(i) is not considered an agent of the candidate or committee as

1 long as the person has no authority to authorize expenditures or make
2 decisions on behalf of the candidate or committee.

3 (3) Contributions other than money or its equivalent are deemed
4 to have a monetary value equivalent to the fair market value of the
5 contribution. Services or property or rights furnished at less than
6 their fair market value for the purpose of assisting any candidate or
7 political committee are deemed a contribution. Such a contribution
8 must be reported as an in-kind contribution at its fair market value
9 and counts towards any applicable contribution limit of the provider.

10 NEW SECTION. **Sec. 217.** "Depository" means a bank, mutual
11 savings bank, savings and loan association, or credit union doing
12 business in this state.

13 NEW SECTION. **Sec. 218.** "Elected official" means any person
14 elected at a general or special election to any public office, and
15 any person appointed to fill a vacancy in any such office.

16 NEW SECTION. **Sec. 219.** "Election" includes any primary,
17 general, or special election for public office and any election in
18 which a ballot proposition is submitted to the voters. An election in
19 which the qualifications for voting include other than those
20 requirements set forth in Article VI, section 1 (Amendment 63) of the
21 Constitution of the state of Washington shall not be considered an
22 election for purposes of this title.

23 NEW SECTION. **Sec. 220.** "Election campaign" means any campaign
24 in support of or in opposition to a candidate for election to public
25 office and any campaign in support of, or in opposition to, a ballot
26 proposition.

27 NEW SECTION. **Sec. 221.** "Election cycle" means the period
28 beginning on the first day of January after the date of the last
29 previous general election for the office that the candidate seeks and
30 ending on December 31st after the next election for the office. In
31 the case of a special election to fill a vacancy in an office,
32 "election cycle" means the period beginning on the day the vacancy
33 occurs and ending on December 31st after the special election.

1 NEW SECTION. **Sec. 222.** (1) "Electioneering communication" means
2 any broadcast, cable, or satellite television, radio transmission,
3 digital communication, United States postal service mailing,
4 billboard, newspaper, or periodical that:

5 (a) Clearly identifies a candidate for a state, local, or
6 judicial office either by specifically naming the candidate, or
7 identifying the candidate without using the candidate's name;

8 (b) Is broadcast, transmitted electronically or by other means,
9 mailed, erected, distributed, or otherwise published within 60 days
10 before any election for that office in the jurisdiction in which the
11 candidate is seeking election; and

12 (c) Either alone, or in combination with one or more
13 communications identifying the candidate by the same sponsor during
14 the 60 days before an election, has a fair market value or cost of
15 \$1,000 or more.

16 (2) "Electioneering communication" does not include:

17 (a) Usual and customary advertising of a business owned by a
18 candidate, even if the candidate is mentioned in the advertising when
19 the candidate has been regularly mentioned in that advertising
20 appearing at least 12 months preceding the candidate becoming a
21 candidate;

22 (b) Advertising for candidate debates or forums when the
23 advertising is paid for by or on behalf of the debate or forum
24 sponsor, so long as two or more candidates for the same position have
25 been invited to participate in the debate or forum;

26 (c) A news item, feature, commentary, or editorial in a regularly
27 scheduled news medium that is:

28 (i) Of interest to the public;

29 (ii) In a news medium controlled by a person whose business is
30 that news medium; and

31 (iii) Not a medium controlled by a candidate or a political or
32 incidental committee;

33 (d) Slate cards and sample ballots;

34 (e) Advertising for books, films, dissertations, or similar works
35 (i) written by a candidate when the candidate entered into a contract
36 for such publications or media at least 12 months before becoming a
37 candidate, or (ii) written about a candidate;

38 (f) Public service announcements;

39 (g) An internal political communication primarily limited to the
40 members of or contributors to a political party organization or

1 political or incidental committee, or to the officers, management
2 staff, or stockholders of a corporation or similar enterprise, or to
3 the members of a labor organization or other membership organization;

4 (h) An expenditure by or contribution to the authorized committee
5 of a candidate for state, local, or judicial office; or

6 (i) Any other communication exempted by the commission through
7 rule consistent with the intent of this title.

8 NEW SECTION. **Sec. 223.** "Expenditure" includes a payment,
9 contribution, subscription, distribution, loan, advance, deposit, or
10 gift of money or anything of value, and includes a contract, promise,
11 or agreement, whether or not legally enforceable, to make an
12 expenditure. "Expenditure" also includes a promise to pay, a payment,
13 or a transfer of anything of value in exchange for goods, services,
14 property, facilities, or anything of value for the purpose of
15 assisting, benefiting, or honoring any public official or candidate,
16 or assisting in furthering or opposing any election campaign. For the
17 purposes of this title, agreements to make expenditures, contracts,
18 and promises to pay may be reported as estimated obligations until
19 actual payment is made. "Expenditure" shall not include the partial
20 or complete repayment by a candidate or political or incidental
21 committee of the principal of a loan, the receipt of which loan has
22 been properly reported.

23 NEW SECTION. **Sec. 224.** "Final report" means the report
24 described as a final report in RCW 42.17A.235(11)(a) (as recodified
25 by this act).

26 NEW SECTION. **Sec. 225.** "Foreign national" means:
27 (1) An individual who is not a citizen of the United States and
28 is not lawfully admitted for permanent residence;
29 (2) A government, or subdivision, of a foreign country;
30 (3) A foreign political party; and
31 (4) Any entity, such as a partnership, association, corporation,
32 organization, or other combination of persons, that is organized
33 under the laws of or has its principal place of business in a foreign
34 country.

35 NEW SECTION. **Sec. 226.** "General election," for the purposes of
36 RCW 42.17A.405 (as recodified by this act), means the election that

1 results in the election of a person to a state or local office. It
2 does not include a primary.

3 NEW SECTION. **Sec. 227.** "Gift" has the definition in RCW
4 42.52.010.

5 NEW SECTION. **Sec. 228.** "Immediate family" includes the spouse
6 or domestic partner, dependent children, and other dependent
7 relatives, if living in the household. For the purposes of the
8 definition of "intermediary" in section 232 of this act, "immediate
9 family" means an individual's spouse or domestic partner, and child,
10 stepchild, grandchild, parent, stepparent, grandparent, brother, half
11 brother, sister, or half sister of the individual and the spouse or
12 the domestic partner of any such person and a child, stepchild,
13 grandchild, parent, stepparent, grandparent, brother, half brother,
14 sister, or half sister of the individual's spouse or domestic partner
15 and the spouse or the domestic partner of any such person.

16 NEW SECTION. **Sec. 229.** "Incidental committee" means any
17 nonprofit organization not otherwise defined as a political committee
18 but that may incidentally make a contribution or an expenditure in
19 excess of the reporting thresholds in RCW 42.17A.235 (as recodified
20 by this act), directly or through a political committee. Any
21 nonprofit organization is not an incidental committee if it is only
22 remitting payments through the nonprofit organization in an
23 aggregated form and the nonprofit organization is not required to
24 report those payments in accordance with this title.

25 NEW SECTION. **Sec. 230.** "Incumbent" means a person who is in
26 present possession of an elected office.

27 NEW SECTION. **Sec. 231.** (1) "Independent expenditure" means an
28 expenditure that has each of the following elements:

29 (a) It is made in support of or in opposition to a candidate for
30 office by a person who is not:

31 (i) A candidate for that office;

32 (ii) An authorized committee of that candidate for that office;

33 and

34 (iii) A person who has received the candidate's encouragement or
35 approval to make the expenditure, if the expenditure pays in whole or

1 in part for political advertising supporting that candidate or
2 promoting the defeat of any other candidate or candidates for that
3 office;

4 (b) It is made in support of or in opposition to a candidate for
5 office by a person with whom the candidate has not collaborated for
6 the purpose of making the expenditure, if the expenditure pays in
7 whole or in part for political advertising supporting that candidate
8 or promoting the defeat of any other candidate or candidates for that
9 office;

10 (c) The expenditure pays in whole or in part for political
11 advertising that either specifically names the candidate supported or
12 opposed, or clearly and beyond any doubt identifies the candidate
13 without using the candidate's name; and

14 (d) The expenditure, alone or in conjunction with another
15 expenditure or other expenditures of the same person in support of or
16 opposition to that candidate, has a value of \$1,000 or more. A series
17 of expenditures, each of which is under \$1,000, constitutes one
18 independent expenditure if their cumulative value is \$1,000 or more.

19 (2) "Independent expenditure" does not include: Ordinary home
20 hospitality; communications with journalists or editorial staff
21 designed to elicit a news item, feature, commentary, or editorial in
22 a regularly scheduled news medium that is of primary interest to the
23 general public, controlled by a person whose business is that news
24 medium, and not controlled by a candidate or a political committee;
25 participation in the creation of a publicly funded voters' pamphlet
26 statement in written or video form; an internal political
27 communication primarily limited to contributors to a political party
28 organization or political action committee, the officers, management
29 staff, and stockholders of a corporation or similar enterprise, or
30 the members of a labor organization or other membership organization;
31 or the rendering of personal services of the sort commonly performed
32 by volunteer campaign workers or incidental expenses personally
33 incurred by volunteer campaign workers not in excess of \$250
34 personally paid for by the worker.

35 NEW SECTION. **Sec. 232.** (1) "Intermediary" means an individual
36 who transmits a contribution to a candidate or committee from another
37 person unless the contribution is from the individual's employer,
38 immediate family, or an association to which the individual belongs.

(2) A treasurer or a candidate is not an intermediary for purposes of the committee that the treasurer or candidate serves.

(3) A professional fund-raiser is not an intermediary if the fund-raiser is compensated for fund-raising services at the usual and customary rate.

(4) A volunteer hosting a fund-raising event at the individual's home is not an intermediary for purposes of that event.

NEW SECTION. **Sec. 233.** "Legislation" means bills, resolutions, motions, amendments, nominations, and other matters pending or proposed in either house of the state legislature, and includes any other matter that may be the subject of action by either house or any committee of the legislature and all bills and resolutions that, having passed both houses, are pending approval by the governor.

NEW SECTION. **Sec. 234.** "Legislative office" means the office of a member of the state house of representatives or the office of a member of the state senate.

NEW SECTION. **Sec. 235.** "Lobby" and "lobbying" each mean attempting to influence the passage or defeat of any legislation by the legislature of the state of Washington, or the adoption or rejection of any rule, standard, rate, or other legislative enactment of any state agency under the state administrative procedure act, chapter 34.05 RCW. Neither "lobby" nor "lobbying" includes an association's or other organization's act of communicating with the members of that association or organization.

NEW SECTION. **Sec. 236.** "Lobbyist" includes any person who lobbies either on the person's own or another's behalf.

NEW SECTION. **Sec. 237.** "Lobbyist's employer" means the person or persons by whom a lobbyist is employed and all persons by whom the lobbyist is compensated for acting as a lobbyist.

NEW SECTION. **Sec. 238.** "Ministerial functions" means an act or duty carried out as part of the duties of an administrative office without exercise of personal judgment or discretion.

1 NEW SECTION. **Sec. 239.** "Participate" means that, with respect
2 to a particular election, an entity:

3 (1) Makes either a monetary or in-kind contribution to a
4 candidate;

5 (2) Makes an independent expenditure or electioneering
6 communication in support of or opposition to a candidate;

7 (3) Endorses a candidate before contributions are made by a
8 subsidiary corporation or local unit with respect to that candidate
9 or that candidate's opponent;

10 (4) Makes a recommendation regarding whether a candidate should
11 be supported or opposed before a contribution is made by a subsidiary
12 corporation or local unit with respect to that candidate or that
13 candidate's opponent; or

14 (5) Directly or indirectly collaborates or consults with a
15 subsidiary corporation or local unit on matters relating to the
16 support of or opposition to a candidate including, but not limited

belief that those entrusted with the offices of government have

1 nothing to fear from full public disclosure of their financial and
2 business holdings, provided those officials deal honestly and fairly
3 with the people.

4 (5) That public confidence in government at all levels is
5 essential and must be promoted by all possible means.

6 (6) That public confidence in government at all levels can best
7 be sustained by assuring the people of the impartiality and honesty
8 of the officials in all public transactions and decisions.

9 (7) That the concept of attempting to increase financial
10 participation of individual contributors in political campaigns is
11 encouraged by the passage of the Revenue Act of 1971 by the Congress
12 of the United States, and in consequence thereof, it is desirable to
13 have implementing legislation at the state level.

14 (8) That the concepts of disclosure and limitation of election
15 campaign financing are established by the passage of the Federal
16 Election Campaign Act of 1971 by the Congress of the United States,
17 and in consequence thereof it is desirable to have implementing
18 legislation at the state level.

19 (9) That small contributions by individual contributors are to be
20 encouraged, and that not requiring the reporting of small
21 contributions may tend to encourage such contributions.

22 (10) That the public's right to know of the financing of
23 political campaigns and lobbying and the financial affairs of elected
24 officials and candidates far outweighs any right that these matters
25 remain secret and private.

26 (11) That, mindful of the right of individuals to privacy and of
27 the desirability of the efficient administration of government, full
28 access to information concerning the conduct of government on every
29 level must be assured as a fundamental and necessary precondition to
30 the sound governance of a free society.

31 The provisions of this (~~chapter~~) title shall be liberally
32 construed to promote complete disclosure of all information
33 respecting the financing of political campaigns and lobbying, and the
34 financial affairs of elected officials and candidates, and full
35 access to public records so as to assure continuing public confidence
36 of fairness of elections and governmental processes, and so as to
37 assure that the public interest will be fully protected. In promoting
38 such complete disclosure, however, this (~~chapter~~) title shall be
39 enforced so as to ensure that the information disclosed will not be
40 misused for arbitrary and capricious purposes and to ensure that all

1 persons reporting under this ((chapter)) title will be protected from
2 harassment and unfounded allegations based on information they have
3 freely disclosed.

(2) A manifestly unreasonable hardship exists if reporting the name of an entity required to be reported under RCW 42.17A.710(1)(g)(ii) (as recodified by this act) would be likely to adversely affect the competitive position of any entity in which the person filing the report, or any member of the person's immediate family, holds any office, directorship, general partnership interest, or an ownership interest of (~~ten~~) 10 percent or more.

(3) Requests for reporting modifications may be heard in a brief adjudicative proceeding as set forth in RCW 34.05.482 through 34.05.494 and in accordance with the standards established in this section. The commission, the commission chair acting as presiding officer, or another commissioner appointed by the chair to serve as presiding officer, may preside over a brief adjudicatory proceeding. If a modification is requested by a filer because of a concern for personal safety, the information submitted regarding that safety concern shall not be made public prior to, or at, the hearing on the

(b) On the (~~tenth~~) 10th day of the first full month after the election.

(3)(a) Each treasurer of a candidate or political committee shall file with the commission a report on the (~~tenth~~) 10th day of each month during which the candidate or political committee is not participating in an election campaign, only if the committee has received a contribution or made an expenditure in the preceding calendar month and either the total contributions received or total expenditures made since the last such report exceed two hundred dollars.

(b) Each incidental committee shall file with the commission a report on the (~~tenth~~) 10th day of each month during which the incidental committee is not otherwise required to report under this section only if the committee has:

(i) Received a payment that would change the information required under RCW 42.17A.240(2)(d) (as recodified by this act) as included in its last report; or

(ii) Made any election campaign expenditure reportable under RCW 42.17A.240(~~(+6)~~) (7) (as recodified by this act) since its last report, and the total election campaign expenditures made since the last report exceed two hundred dollars.

(4) The report filed (~~twenty-one~~) 21 days before the election shall report all contributions received and expenditures made as of the end of one business day before the date of the report. The report filed seven days before the election shall report all contributions received and expenditures made as of the end of one business day before the date of the report. Reports filed on the (~~tenth~~) 10th day of the month shall report all contributions received and expenditures made from the closing date of the last report filed through the last day of the month preceding the date of the current report.

(5) For the period beginning the first day of the fourth month preceding the date of the special election, or for the period beginning the first day of the fifth month before the date of the general election, and ending on the date of that special or general election, each Monday the treasurer for a candidate or a political

1 committee shall file with the commission a report of each bank
2 deposit made during the previous seven calendar days. The report
3 shall contain the name of each person contributing the funds and the
4 amount contributed by each person. However, persons who contribute no
5 more than twenty-five dollars in the aggregate are not required to be
6 identified in the report. A copy of the report shall be retained by
7 the treasurer for the treasurer's records. In the event of deposits
8 made by candidates, political committee members, or paid staff other
9 than the treasurer, the copy shall be immediately provided to the

29 political committee for whose benefit the contribution is earmarked,
30 the amount of the contribution, and the date that the contribution
31 was received; and

32 (3) Mail or deliver to the commission and the candidate or
33 political committee benefiting from the contribution a copy of the
34 "Earmarked contributions" report within two working days of receipt
35 of the contribution.

36 (4) A candidate or political committee receiving notification of
37 an earmarked contribution under subsection (3) of this section shall
38 report the contribution, once notification of the contribution is
39 received by the candidate or committee, in the same manner as any

1 other contribution, as required by RCW 42.17A.235 (as recodified by
2 this act) and 42.17A.240 (as recodified by this act).

3 **Sec. 433.** RCW 42.17A.300 and 2010 c 204 s 501 are each amended
4 to read as follows:

5 (1) The legislature finds that:

6 (a) Timely disclosure to voters of the identity and sources of
7 funding for electioneering communications is vitally important to the
8 integrity of state, local, and judicial elections.

9 (b) Electioneering communications that identify political
10 candidates for state, local, or judicial office and that are
11 distributed (~~(sixty)~~) 60 days before an election for those offices
12 are intended to influence voters and the outcome of those elections.

13 (c) The state has a compelling interest in providing voters
14 information about electioneering communications in political
15 campaigns concerning candidates for state, local, or judicial office
16 so that voters can be fully informed as to the: (i) Source of support
17 or opposition to those candidates; and (ii) identity of persons
18 attempting to influence the outcome of state, local, and judicial
19 candidate elections.

20 (d) Nondisclosure of financial information about advertising that
21 masquerades as relating only to issues and not to candidate campaigns
22 fosters corruption or the appearance of corruption. These
23 consequences can be substantially avoided by full disclosure of the
24 identity and funding of those persons paying for such advertising.

25 (e) The United States supreme court held in *McConnell et al. v.*
26 *Federal Elections Commission*, 540 U.S. 93, 124 S.Ct. 619, 157 L.Ed.2d
27 491 (2003) that speakers seeking to influence elections do not
28 possess an inviolable free speech right to engage in electioneering
29 communications regarding elections, including when issue advocacy is
30 the functional equivalent of express advocacy. Therefore, such
31 election campaign communications can be regulated and the source of
32 funding disclosed.

33 (f) The state has a sufficiently compelling interest in
34 preventing corruption in political campaigns to justify and restore
35 contribution limits and restrictions on the use of soft money in RCW
36 42.17A.405 (as recodified by this act). Those interests include
37 restoring restrictions on the use of such funds for electioneering
38 communications, as well as the laws preventing circumvention of those
39 limits and restrictions.

(2) Based upon the findings in this section, chapter 445, Laws of 2005 is narrowly tailored to accomplish the following and is intended to:

(a) Improve the disclosure to voters of information concerning persons and entities seeking to influence state, local, and judicial campaigns through reasonable and effective mechanisms, including improving disclosure of the source, identity, and funding of electioneering communications concerning state, local, and judicial candidate campaigns;

(b) Regulate electioneering communications that mention state, local, and judicial candidates and that are broadcast, mailed, erected, distributed, or otherwise published right before the election so that the public knows who is paying for such communications;

(c) Reenact and amend the contribution limits in RCW 42.17A.405 (7) and (15) (as recodified by this act) and the restrictions on the use of soft money, including as applied to electioneering communications, as those limits and restrictions were in effect following the passage of chapter 2, Laws of 1993 (Initiative Measure No. 134) and before the state supreme court decision in *Washington State Republican Party v. Washington State Public Disclosure Commission*, 141 Wn.2d 245, 4 P.3d 808 (2000). The commission is authorized to fully restore the implementation of the limits and restrictions of RCW 42.17A.405 (7) and (15) (as recodified by this act) in light of *McConnell et al. v. Federal Elections Commission*, 540 U.S. 93, 124 S.Ct. 619, 157 L.Ed.2d 491 (2003). The United States supreme court upheld the disclosure and regulation of electioneering communications in political campaigns, including but not limited to issue advocacy that is the functional equivalent of express advocacy; and

(d) Authorize the commission to adopt rules to implement chapter 445, Laws of 2005.

Sec. 434. RCW 42.17A.305 and 2020 c 152 s 8 are each amended to read as follows:

(1) A payment for or promise to pay for any electioneering communication shall be reported to the commission by the sponsor on forms the commission shall develop by rule to include, at a minimum, the following information:

(a) Name and address of the sponsor;

(b) Source of funds for the communication, including:

(i) General treasury funds. The name and address of businesses, unions, groups, associations, or other organizations using general treasury funds for the communication, however, if a business, union, group, association, or other organization undertakes a special solicitation of its members or other persons for an electioneering communication, or it otherwise receives funds for an electioneering communication, that entity shall report pursuant to (b)(ii) of this subsection;

(ii) Special solicitations and other funds. The name, address, and, for individuals, occupation and employer, of a person whose funds were used to pay for the electioneering communication, along with the amount, if such funds from the person have exceeded two hundred fifty dollars in the aggregate for the electioneering communication;

(iii) A statement from the sponsor that:

(A) The electioneering communication is not financed in any part by a foreign national; and

(B) Foreign nationals are not involved in making decisions regarding the electioneering communication in any way; and

(iv) Any other source information required or exempted by the commission by rule;

(c) Name and address of the person to whom an electioneering communication related expenditure was made;

(d) A detailed description of each expenditure of more than one hundred dollars;

(e) The date the expenditure was made and the date the electioneering communication was first broadcast, transmitted, mailed, erected, distributed, or otherwise published;

(f) The amount of the expenditure;

(g) The name of each candidate clearly identified in the electioneering communication, the office being sought by each candidate, and the amount of the expenditure attributable to each candidate; and

(h) Any other information the commission may require or exempt by rule.

(2) Electioneering communications shall be reported as follows: The sponsor of an electioneering communication shall report to the commission within ~~((twenty-four))~~ 24 hours of, or on the first working day after, the date the electioneering communication is

1 broadcast, transmitted, mailed, erected, distributed, digitally or
2 otherwise, or otherwise published.

3 (3) Electioneering communications shall be reported
4 electronically by the sponsor using software provided or approved by
5 the commission. The commission may make exceptions on a case-by-case
6 basis for a sponsor who lacks the technological ability to file
7 reports using the electronic means provided or approved by the
8 commission.

9 (4) All persons required to report under RCW 42.17A.225 (as
10 recodified by this act), 42.17A.235 (as recodified by this act),
11 42.17A.240 (as recodified by this act), and 42.17A.255 (as recodified
12 by this act) are subject to the requirements of this section,
13 although the commission may determine by rule that persons filing
14 according to those sections may be exempt from reporting some of the

16 determine that reports filed pursuant to this section also satisfy
17 the requirements of RCW 42.17A.255 (as recodified by this act) and
18 42.17A.260 (as recodified by this act).

19 (5) Failure of any sponsor to report electronically under this
20 section shall be a violation of this ~~((chapter))~~ title.

21 **Sec. 435.** RCW 42.17A.310 and 2010 c 204 s 503 are each amended
22 to read as follows:

23 (1) An electioneering communication made by a person in
24 cooperation, consultation, or concert with, or at the request or
25 suggestion of, a candidate, a candidate's authorized committee, or
26 their agents is a contribution to the candidate.

27 (2) An electioneering communication made by a person in
28 cooperation, consultation, or concert with, or at the request or
29 suggestion of, a political committee or its agents is a contribution
30 to the political committee.

31 (3) If an electioneering communication is not a contribution
32 pursuant to subsection (1) or (2) of this section, the sponsor shall
33 file an affidavit or declaration so stating at the time the sponsor
34 is required to report the electioneering communication expense under
35 RCW 42.17A.305 (as recodified by this act).

36 **Sec. 436.** RCW 42.17A.315 and 2010 c 204 s 504 are each amended
37 to read as follows:

(1) The sponsor of an electioneering communication shall preserve all financial records relating to the communication, including books of account, bills, receipts, contributor information, and ledgers, for not less than five calendar years following the year in which the communication was broadcast, transmitted, mailed, erected, or otherwise published.

(2) All reports filed under RCW 42.17A.305 (as recodified by this act) shall be certified as correct by the sponsor. 2 listing of the names of the three individuals or entities, other than
3 political committees, making the largest aggregated contributions as
4 determined by RCW 42.17A.350(2) (as recodified by this act); and

5 (c) If the sponsor is a political committee established,
6 maintained, or controlled directly, or indirectly through the
7 formation of one or more political committees, by an individual,
8 corporation, union, association, or other entity, the full name of
9 that individual or entity.

10 (3) The information required by subsections (1) and (2) of this
11 section shall:

12 (a) Appear on the first page or fold of the written advertisement
13 or communication in at least (~~ten~~) 10-point type, or in type at
14 least ten percent of the largest size type used in a written
15 advertisement or communication directed at more than one voter, such
16 as a billboard or poster, whichever is larger;

17 (b) Not be subject to the half-tone or screening process; and

18 (c) Be set apart from any other printed matter. No text may be
19 before, after, or immediately adjacent to the information required by
20 subsections (1) and (2) of this section.

21 (4) In an independent expenditure or electioneering communication
22 transmitted via television or other medium that includes a visual
23 image, the following statement must either be clearly spoken, or
24 appear in print and be visible for at least four seconds, appear in
25 letters greater than four percent of the visual screen height on a
26 solid black background on the entire bottom one-third of the
27 television or visual display screen, or bottom one-fourth of the
28 screen if the sponsor does not have or is otherwise not required to
29 list its top five contributors, and have a reasonable color contrast
30 with the background: "No candidate authorized this ad. Paid for by
31 (name, city, state)." If the advertisement or communication is
32 undertaken by a nonindividual other than a party organization, then
33 the following notation must also be included: "Top Five Contributors"
34 followed by a listing of the names of the five persons making the
35 largest aggregate contributions as determined by RCW 42.17A.350(1)
36 (as recodified by this act); and if necessary, the statement "Top
37 Three Donors to PAC Contributors," followed by a listing of the names
38 of the three individuals or entities other than political committees
39 making the largest aggregate contributions to political committees as
40 determined by RCW 42.17A.350(2) (as recodified by this act).

1 Abbreviations may be used to describe contributing entities if the
2 full name of the entity has been clearly spoken previously during the
3 broadcast advertisement.

4 (5) The following statement shall be clearly spoken in an
5 independent expenditure or electioneering communication transmitted
6 by a method that does not include a visual image: "No candidate
7 authorized this ad. Paid for by (name, city, state)." If the
8 independent expenditure or electioneering communication is undertaken
9 by a nonindividual other than a party organization, then the
10 following statement must also be included: "Top Five Contributors"
11 followed by a listing of the names of the five persons making the
12 largest contributions as determined by RCW 42.17A.350(1) (as
13 recodified by this act); and if necessary, the statement "Top Three
14 Donors to PAC Contributors," followed by a listing of the names of
15 the three individuals or entities, other than political committees,
16 making the largest aggregate contributions to political committees as
17 determined by RCW 42.17A.350(2) (as recodified by this act).
18 Abbreviations may be used to describe contributing entities if the
19 full name of the entity has been clearly spoken previously during the

21 (6) Political advertising costing one thousand dollars or more
22 supporting or opposing ballot measures sponsored by a political
23 committee must include the information on the top five contributors
24 and top three contributors, other than political committees, as
25 required by RCW 42.17A.350 (as recodified by this act). A series of
26 political advertising sponsored by the same political committee, each
27 of which is under one thousand dollars, must include the top five
28 contributors and top three contributors, other than political
29 committees, as required by RCW 42.17A.350 (as recodified by this act)
30 once their cumulative value reaches one thousand dollars or more.

31 (7) Political yard signs are exempt from the requirements of this
32 section that the sponsor's name and address, and the top five

(8) For the purposes of this section, "yard sign" means any outdoor sign with dimensions no greater than eight feet by four feet.

At least one picture of the candidate used in any political advertising shall have been taken within the last five years and shall be no smaller than any other picture of the same candidate used in the same advertisement.

Sec. 439. RCW 42.17A.335 and 2009 c 222 s 2 are each amended to read as follows:

(1) It is a violation of this (~~chapter~~) title for a person to sponsor with actual malice a statement constituting libel or defamation per se under the following circumstances:

(a) Political advertising or an electioneering communication that contains a false statement of material fact about a candidate for public office;

(b) Political advertising or an electioneering communication that falsely represents that a candidate is the incumbent for the office sought when in fact the candidate is not the incumbent;

(c) Political advertising or an electioneering communication that makes either directly or indirectly, a false claim stating or implying the support or endorsement of any person or organization when in fact the candidate does not have such support or endorsement.

(2) For the purposes of this section, "libel or defamation per se" means statements that tend (a) to expose a living person to hatred, contempt, ridicule, or obloquy, or to deprive him or her of the benefit of public confidence or social intercourse, or to injure him or her in his or her business or occupation, or (b) to injure any person, corporation, or association in his, her, or its business or occupation.

(3) It is not a violation of this section for a candidate or his or her agent to make statements described in subsection (1)(a) or (b) of this section about the candidate himself or herself because a person cannot defame himself or herself. It is not a violation of this section for a person or organization referenced in subsection (1)(c) of this section to make a statement about that person or organization because such persons and organizations cannot defame themselves.

1 (4) Any violation of this section shall be proven by clear and
2 convincing evidence. If a violation is proven, damages are presumed
3 and do not need to be proven.

4 **Sec. 440.** RCW 42.17A.340 and 2010 c 204 s 507 are each amended

4 (a) The financial strength of certain individuals or
5 organizations should not permit them to exercise a disproportionate
6 or controlling influence on the election of candidates.

7 (b) Rapidly increasing political campaign costs have led many
8 candidates to raise larger percentages of money from special
9 interests with a specific financial stake in matters before state
10 government. This has caused the public perception that decisions of

5 committee probably affected the outcome of any election, the result
6 of that election may be held void and a special election held within
7 (~~(sixty)~~) 60 days of the finding. Any action to void an election
8 shall be commenced within one year of the date of the election in
9 question. It is intended that this remedy be imposed freely in all
10 appropriate cases to protect the right of the electorate to an
11 informed and knowledgeable vote.

2 financing, staffing, or size of the respondent's campaign or
3 organization;

4 (iv) The amount of financial activity by the respondent during
5 the statement period or election cycle;

6 (v) Whether the late or unreported activity was within three
7 times the contribution limit per election, including in proportion to
8 the total amount of expenditures by the respondent in the campaign or
9 statement period;

10 (vi) Whether the respondent or any person benefited politically
11 or economically from the noncompliance;

12 (vii) Whether there was a personal emergency or illness of the
13 respondent or member of the respondent's immediate family;

14 (viii) Whether other emergencies such as fire, flood, or utility
15 failure prevented filing;

16 (ix) Whether there was commission staff or equipment error,
17 including technical problems at the commission that prevented or
18 delayed electronic filing;

19 (x) The respondent's demonstrated good-faith uncertainty
20 concerning commission staff guidance or instructions;

21 (xi) Whether the respondent is a first-time filer;

22 (xii) Good faith efforts to comply, including consultation with
23 commission staff prior to initiation of enforcement action and
24 cooperation with commission staff during enforcement action and a
25 demonstrated wish to acknowledge and take responsibility for the
26 violation;

27 (xiii) Penalties imposed in factually similar cases; and

28 (xiv) Other factors relevant to the particular case.

21 (c) A person who, with actual malice, procures or offers any
22 false or forged document to be filed, registered, or recorded with
23 the commission under this ((chapter)) title is guilty of a class C
24 felony under chapter 9.94A RCW.

(iii) Any statement is made that implies that the whole or any part of the proceeds from the sale will be applied toward any charitable purpose or donated to any charitable organization.

(b) The solicitation shall be deemed completed when made, whether or not the person making it receives any contribution or makes any sale.

(c) "Solicitation" does not include bingo activities, raffles, and amusement games conducted under chapter 9.46 RCW and applicable rules of the Washington state gambling commission.

(20) "Solicitation report" means the financial information the secretary requires pursuant to RCW 19.09.075 or 19.09.079.

Sec. 504. RCW 28A.600.027 and 2018 c 125 s 2 are each amended to read as follows:

(1) Student editors of school-sponsored media are responsible for determining the news, opinion, feature, and advertising content of the media subject to the limitations of subsection (2) of this section. This subsection does not prevent a student media adviser from teaching professional standards of English and journalism to the student journalists. A student media adviser may not be terminated, transferred, removed, or otherwise disciplined for complying with this section.

(2) School officials may only prohibit student expression that:

(a) Is libelous or slanderous;
(b) Is an unwarranted invasion of privacy;
(c) Violates federal or state laws, rules, or regulations;
(d) Incites students to violate federal or state laws, rules, or regulations;

(e) Violates school district policy or procedure related to harassment, intimidation, or bullying pursuant to RCW 28A.300.285 or the prohibition on discrimination pursuant to RCW 28A.642.010;

(f) Inciting of students so as to create a clear and present danger of:

(i) The commission of unlawful acts on school premises;

(ii) The violation of lawful school district policy or procedure; or

(iii) The material and substantial disruption of the orderly operation of the school. A school official must base a forecast of material and substantial disruption on specific facts, including past experience in the school and current events influencing student behavior, and not on undifferentiated fear or apprehension; or

(g) Is in violation of the federal communications act or applicable federal communication commission rules or regulations.

(3) Political expression by students in school-sponsored media shall not be deemed the use of public funds for political purposes, for purposes of the prohibitions of RCW 42.17A.550 (as recodified by this act).

(4) Any student, individually or through his or her parent or guardian, enrolled in a public high school may file an appeal of any alleged violation of subsection (1) of this section pursuant to chapter 28A.645 RCW.

(5) Expression made by students in school-sponsored media is not necessarily the expression of school policy. Neither a school official nor the governing board of the school or school district may be held responsible in any civil or criminal action for any expression made or published by students in school-sponsored media.

(6) Each school district that includes a high school shall adopt a written student freedom of expression policy in accordance with this section. The policy may include reasonable provisions for the time, place, and manner of student expression.

(7) The definitions in this subsection apply throughout this section unless the context clearly requires otherwise.

(a) "School-sponsored media" means any matter that is prepared, substantially written, published, or broadcast by student journalists, that is distributed or generally made available, either free of charge or for a fee, to members of the student body, and that is prepared under the direction of a student media adviser. "School-sponsored media" does not include media that is intended for distribution or transmission solely in the classrooms in which they are produced.

1 (b) "Student journalist" means a student who gathers, compiles,
2 writes, edits, photographs, records, or prepares information for
3 dissemination in school-sponsored media.

4 (c) "Student media adviser" means a person who is employed,
5 appointed, or designated by the school to supervise, or provide
6 instruction relating to, school-sponsored media.

(d) Payments by a governmental or nongovernmental entity of reasonable expenses incurred in connection with a speech, presentation, appearance, or trade mission made in an official capacity. As used in this subsection, "reasonable expenses" are limited to travel, lodging, and subsistence expenses incurred the day before through the day after the event;

(e) Items a state officer or state employee is authorized by law to accept;

(f) Payment of enrollment and course fees and reasonable travel expenses attributable to attending seminars and educational programs sponsored by a bona fide governmental or nonprofit professional, educational, trade, or charitable association or institution. As used in this subsection, "reasonable expenses" are limited to travel, lodging, and subsistence expenses incurred the day before through the day after the event;

(g) Items returned by the recipient to the donor within ((thirty)) 30 days of receipt or donated to a charitable organization within ((thirty)) 30 days of receipt;

(h) Campaign contributions reported under ((chapter 42.17A)) Title 29B RCW;

(i) Discounts available to an individual as a member of an employee group, occupation, or similar broad-based group; and

(j) Awards, prizes, scholarships, or other items provided in recognition of academic or scientific achievement.

1 (10) "Head of agency" means the chief executive officer of an
2 agency. In the case of an agency headed by a commission, board,

(1) No state officer or state employee may accept gifts, other than those specified in subsections (2) and (5) of this section, with an aggregate value in excess of fifty dollars from a single source in a calendar year or a single gift from multiple sources with a value in excess of fifty dollars. For purposes of this section, "single source" means any person, as defined in RCW 42.52.010, whether acting directly or through any agent or other intermediary, and "single gift" includes any event, item, or group of items used in conjunction with each other or any trip including transportation, lodging, and attendant costs, not excluded from the definition of gift under RCW 42.52.010. 35 food and beverage that exceed fifty dollars on a single occasion
36 shall be reported as provided in (~~chapter 42.17A~~) Title 29B RCW.

1 (1) No state officer or state employee may use or authorize the
2 use of facilities of an agency, directly or indirectly, for the

14 (ii) Posting, by a legislator or appropriate legislative staff
15 designee, information to a legislator's official legislative website
16 including an official legislative social media account, about:

17 (A) Emergencies;

18 (B) Federal holidays, state and legislatively recognized holidays
19 established under RCW 1.16.050, and religious holidays;

20 (C) Information originally provided or published by other
21 government entities which provide information about government
22 resources; and

23 (D) Achievements, honors, or awards of extraordinary distinction;
24 and

25 (e) De minimis use of public facilities by statewide elected
26 officials and legislators incidental to the preparation or delivery
27 of permissible communications, including written and verbal
28 communications initiated by them of their views on ballot
29 propositions that foreseeably may affect a matter that falls within
30 their constitutional or statutory responsibilities.

31 (3) As to state officers and employees, this section operates to
32 the exclusion of RCW 42.17A.555 (as recodified by this act).

33 (4) As used in this section, "official legislative website"

(i) A representative from the commission;

pedestrian, bicyclist, or nonmotorist fatalities;

(iv) A traffic engineer;

(v) A representative from the department of transportation and a
representative from the department of health;

(viii) A representative from a pedestrian advocacy group; and

(ix) A representative from a bicyclist or other nonmotorist
advocacy group.

(b) The commission may invite other representatives of
stakeholder groups to participate in the council as deemed
appropriate by the commission. Additionally, the commission may

1 invite a victim or family member of a victim to participate in the

3 (4) The council must meet at least quarterly. By December 31st of
4 each year, the council must issue an annual report detailing any
5 findings and recommendations to the governor and the transportation
